High-Need, High-Cost Patients: Challenges and Promising Models

PETER BOLING is a professor of medicine and chair of the Virginia Commonwealth University (VCU) Division of Geriatric Medicine where he is also co-director of the Virginia Geriatric Education Center, a consortium composed of VCU, Eastern Virginia Medical School and the University of Virginia. His academic work and practice focus on care for frail individuals with high co-morbidity, with a particular interest in care coordination, care transitions, home health and new models of care. His team has established the award-winning VCU Center for Advanced Health Management, a level-3 NCQA certified patient centered medical home that supports team-based care through house calls, transitional care, clinic, nursing home care, palliative care and inpatient consults, covering the continuum. He has also been one of the founders of the successful Independence at Home federal demonstration that is testing home-based primary care. Dr. Boling leads the medical school's geriatric student interest group, teaches in pre-clinical courses, has created national educational programs for practicing physicians, and has directed the Virginia Geriatric Society's annual conference for the past 7 years.

KAREN DAVIS is currently the Eugene and Mildred Lipitz Professor in the Department of Health Policy and Management and director of the Roger C. Lipitz Center for Integrated Health Care at the Bloomberg School of Public Health at Johns Hopkins University. Dr. Davis has served as president of The Commonwealth Fund, chairman of the Department of Health Policy and Management at The Johns Hopkins Bloomberg School of Public Health, and deputy assistant secretary for health policy in the Department of Health and Human Services. In addition, she was a senior fellow at the Brookings Institution in Washington, D.C., a visiting lecturer at Harvard University and an assistant professor of economics at Rice University. She received her Ph.D. in economics from Rice University. Dr. Davis also serves on the board of directors of the Geisinger Health System and Geisinger Health Plan and formerly on the board of trustees of ProMedica Health System in Ohio (2012-2014). She is a member of the Kaiser Commission on Medicaid and the Uninsured. She was elected to the Institute of Medicine in 1975, has served two terms on the IOM governing council (1986-1990 and 1997-2000), and was a member of the IOM Committee on Geographic Variation in Health Care Spending. She is also a former member of the Agency for Healthcare Quality and Research (AHRQ) National Advisory Council for Health Care Policy, Research and Evaluation, of the Panel of Health Advisers for the Congressional Budget Office, and a past chairman of AcademyHealth, from whom she received a Distinguished Investigator Award.

KATHERINE HAYES is the director of health policy at the Bipartisan Policy Center. Prior to joining BPC, Ms. Hayes worked as an associate research professor in the Department of Health Policy at the George Washington University School of Public Health and Health Services and served as co-director of Health Reform GPS: Navigating Health Reform Implementation, a website jointly sponsored by the Robert Wood Johnson Foundation and GW's Hirsh Health Law and Policy Program. She also taught graduate courses in federal advocacy and policymaking and the federal budget process. Prior to joining GW, Ms. Hayes served as vice president of health policy for Jennings Policy Strategies, Inc. Other private-sector experience includes legal practice

as a member of the health and legislative practice groups at Hogan & Hartson, LLP (now Hogan Lovells), policy director for two large Catholic health systems, and policy director for Cardinal Glennon Children's Hospital. Her government experience includes serving as legislative counsel to Sen. Evan Bayh, D-Ind., legislative assistant to Sen. John H. Chafee, R-R.I., and Rep. Mickey Leland, D-Texas, and as a program consultant for the State of Missouri Medicaid agency. She also worked as a health and education policy advisor for the State of Texas, Office of State-Federal Relations. Ms. Hayes received a bachelor of arts degree in international studies from the University of North Carolina at Chapel Hill and a juris doctor from The American University Washington College of Law.
