ACA 101: What You Need to Know

SABRINA CORLETTE is a senior research fellow and project director at the Center on Health Insurance Reforms (CHIR) at Georgetown University's Health Policy Institute and an adjunct professor of law at the Georgetown University Law Center. At CHIR she directs research on health insurance reform issues as they affect consumers and patients. Her areas of focus include state and federal regulation of private health insurance plans and markets and implementation of new insurance market rules under the Affordable Care Act (ACA). She provides expertise and strategic advice to individuals and organizations on federal and state health insurance laws and programs and provides technical support through the development of resource guides, white papers, issue briefs, blogs and fact sheets. She has published numerous papers relating to the regulation of private health insurance and the development of health insurance marketplaces under the ACA. Prior to joining the Georgetown faculty, Ms. Corlette was director of health policy programs at the National Partnership for Women & Families, where she provided policy expertise and strategic direction for the organization's advocacy on health care reform, with a particular focus on insurance market reform, benefit design, and the quality and affordability of health care. From 1997 to 2001, Ms. Corlette worked as a professional staff member of the U.S. Senate Health Education, Labor and Pensions (HELP) Committee, where she served as health legislative assistant to Senator Tom Harkin, D-Iowa. After leaving the Hill, Ms. Corlette served as an attorney at the law firm Hogan Lovells (formerly Hogan & Hartson LLP), where she advised clients on health care law and policy relating to HIPAA, Medicare and Medicaid, and the Food, Drug and Cosmetic Act. Ms. Corlette is a member of the D.C. Bar and received her J.D. with high honors from the University of Texas at Austin and her undergraduate degree with honors from Harvard University.

CHARLENE FRIZZERA serves as a senior advisor at Leavitt Partners and is also a member of the firm's FuturePanel. Ms. Frizzera is an outstanding thought leader with exceptional operational knowledge surrounding the Centers for Medicare and Medicaid Services. Prior to joining Leavitt Partners, Ms. Frizzera was Acting Administrator for the Centers for Medicare and Medicaid Services where she was responsible for leading the policy and operational aspects of CMS while executing the design and implementation plan for the recently implemented Affordable Care Act. Ms. Frizzera's CMS career includes positions as chief operating officer, deputy chief operating officer, deputy director for the Center of Medicaid and State Operations. Through the years, Ms. Frizzera led the integration of the agency's programs and policies across components and leading all operational aspects of CMS including budget, information technology and systems, human resources, contracting, administration, and program integrity. She was also able to modernize the information technology infrastructure in CMS, and design and implement an aggressive program for reducing fraud, waste and abuse. Ms. Frizzera received the Presidential Rank Award in 2000 and 2008. This award is received by the top 1 percent of the Senior Executive Service in the country for outstanding leadership.

PAUL FRONSTIN is a senior research associate with the Employee Benefit Research Institute, a private, nonprofit, nonpartisan organization committed to original public policy research and education on economic security and employee benefits. He is also director of the institute's Health Research and Education Program, and oversees the Center for Research on Health Benefits Innovation. He has been with EBRI since 1993. Dr. Fronstin's research interests include trends in employment-based health benefits, private health insurance exchanges, workplace wellness programs, consumer-driven health benefits, retiree health benefits, employee benefits and taxation, and public opinion about health benefits and health care. In 2012, Dr. Fronstin was appointed to the Maryland Health Care Commission. He currently serves on the board of trustees for Emeriti Retirement Health Solutions. He is the associate editor of *Benefits Quarterly* and is also a TIAA-CREF Institute Fellow. In 2010, he served on the Institute of Medicine (IOM) Committee on Determination of Essential Health Benefits. Dr. Fronstin earned his bachelor of science degree from SUNY Binghamton and his Ph.D. in economics from the University of Miami.

DIANE ROWLAND has been director of the Kaiser Commission on Medicaid and the Uninsured since 1991 and overseen the Kaiser Family Foundation's health policy work on Medicaid, Medicare, private insurance, HIV, women's health policy, and disparities since 1993. She is a nationally-recognized health policy expert with a distinguished career in public policy and research focusing on health insurance coverage, access to care, and health care financing for low-income, elderly, and disabled populations. Dr. Rowland frequently testifies on Medicaid, Medicare and health care policy and has published widely on these issues. Appointed in 2009 as the inaugural chair, Dr. Rowland continues to serve as the chair of the congressionally-authorized Medicaid and CHIP Payment and Access Commission (MACPAC) established to advise Congress on issues related to Medicaid and the Children's Health Insurance Program (CHIP). Dr. Rowland is an elected member of the Institute of Medicine and holds a doctor of science (Sc.D.) degree from the Bloomberg School of Public Health at the Johns Hopkins University.

JENNIFER TOLBERT is director of state health reform at the Kaiser Family Foundation and an associate director for the Kaiser Commission on Medicaid and the Uninsured. Ms. Tolbert leads an initiative to monitor state implementation of the Affordable Care Act with a particular focus on state efforts to establish health insurance marketplaces. She also directs research and policy analysis focusing on issues of affordability for low-income populations and areas of intersection between Medicaid and the health insurance marketplaces, such as eligibility and enrollment and consumer assistance. In addition, Ms. Tolbert manages State Health Facts, a source for state-level data on over 600 key health topics. Prior to joining the foundation, Ms. Tolbert served as the assistant vice president for policy at America's Essential Hospitals and before that she worked in the Office of the Assistant Secretary for Planning and Evaluation at the Department of Health and Human Services.
