### **Health Insurance Marketplaces: The First 8 Weeks**

**KATY CALDWELL**, is executive director of the Legacy Community Health Services, Inc., formerly known as Montrose Clinic, a non-profit federally qualified health center, which provides low or no cost health, social and educational services. Prior to her position with Legacy, Ms. Caldwell worked for Quantum Consultants, a government relations and political consulting firm. While at Quantum, she was a legislative consultant for business, local governments and community interests on issues ranging from health care policy to child abuse prevention. From 1991 until 1994, Ms. Caldwell served as the elected treasurer of Harris County. In 1993, Governor Ann Richards appointed her to the board of trustees of the Texas County and District Retirement System that oversees over \$4 billion dollars in retirement funds. Ms. Caldwell has received numerous awards and recognition for her community activities. She is currently on the board of directors of AIDS United, The Harris County Health Alliance, Houston First, Southern AIDS Coalition, and LISC. Ms. Caldwell is a graduate of the University of Houston.

**MILA KOFMAN** is executive director of the DC Health Benefit Exchange Authority. Appointed to the position by a unanimous vote of the board of directors, Ms. Kofman is a nationally-recognized expert on private health insurance markets and has worked with states and all stakeholders to implement health insurance reforms. She is the former superintendent of insurance in Maine, implementing health insurance reforms and working with states to implement the Health Insurance Portability and Accountability Act reforms of the 1990s. Ms. Kofman also has experience studying state-based reform efforts and markets, and working with employer purchasing coalitions seeking to leverage purchasing power for sustainable financing of medical care. From March 2008 to May 2011, Ms. Kofman was superintendent of insurance in Maine where she regulated a multi-billion dollar insurance industry, heading an agency with 70+ staff and a multi-million dollar budget. A gubernatorial appointee, she was nominated and first confirmed in 2008. In 2010, she was renominated and unanimously reconfirmed to a new term.

**MATT SALO** is executive director of the National Association of Medicaid Directors (NAMD). The association represents all 56 of the nation's state and territorial Medicaid directors and provides them with a unified voice in national discussions as well as a locus for technical assistance and best practices. Mr. Salo previously spent 12 years at the National Governors Association, where he worked on the governors' health care and human services reform agendas, and spent the five years prior to that as a health policy analyst working for the state Medicaid directors as part of the American Public Human Services Association. Mr. Salo also spent two years as a substitute teacher in the public school system in Alexandria, VA, and holds a BA in eastern religious studies from the University of Virginia.

**DANIEL J. SCHUYLER** is director at Leavitt Partners and helps guide the firm's health insurance exchange practice. Prior to his work with Leavitt Partners, Mr. Schuyler was the director of technology for the Utah Health Insurance Exchange, where he was responsible for defining the technical goals and business processes associated with the exchange. Utah's exchange was only the second of its kind in the United States when created in 2009. Prior to his post with the Utah Health Insurance Exchange, Mr. Schuyler was manager for the Department of Environmental

Quality, National Environmental Information Exchange Network. While in this role, Mr. Schuyler helped bring the State of Utah from the bottom third in environmental exchanges to the top ten percent in less than one year. Mr. Schuyler holds numerous IT certifications as well as a degree from Lewis University.
