LISA BIELAMOWICZ is the Advisory Board's chief medical officer and its leading expert on physician strategy, serving as a strategic adviser to executives from the nation's largest health systems and medical groups. An author of more than 20 publications, Lisa has provided consultative support to hundreds of hospitals around technology management, service line planning, and new business assessment, and she has managed over 5,000 assessments for member hospitals. Lisa has received numerous academic and professional awards, and was chosen as the 2001 Michael E. DeBakey medical scholar. As a Howard Hughes fellow, she researched memory and learning using functional MRI at the National Institute of Mental Health, resulting in several publications in peer-reviewed scientific journals and presentations at international meetings. Before joining the firm, Lisa trained in diagnostic radiology at Johns Hopkins Hospital. She holds a Bachelor of Science from Rice University and received her M.D. from Baylor College of Medicine with highest honors, graduating first in her class.

FARZAD MOSTASHARI is the CEO of Aledade, a start-up he co-founded aimed at helping primary care doctors transform their practices and form accountable care organizations (ACOs). Prior to Aledade, he was a visiting fellow at the Brookings Institution, where he focused on payment reform and delivery system transformation. He served from 2011-2013 as the national coordinator for health information technology where he coordinated U.S. efforts to build a health information technology infrastructure for health care reform and consumer empowerment. During his tenure at the Office of the National Coordinator, including his two years as principal deputy, he led the implementation of the Health IT for Economic and Clinical Health (HITECH) Act. He also collaborated with the Centers for Medicare & Medicaid Services on the design and implementation of the "meaningful use" incentive program, in addition to programs for health information exchange, health IT workforce, research, and privacy and security. Previously, Dr. Mostashari served at the New York City Department of Health and Mental Hygiene as assistant commissioner for the Primary Care Information Project, where he co-led agile development of population health management functionality within a commercial EHR. Dr. Mostashari also led the NYC Center of Excellence in Public Health Informatics and an Agency for Healthcare Research and Quality-funded project focused on quality measurement at the point of care. He conducted graduate training at the Harvard School of Public Health and Yale Medical School, served his internal medicine residency at Massachusetts General Hospital, and completed the CDC's Epidemic Intelligence Service program. He was a lead investigator in the outbreaks of West Nile virus and anthrax in New York City, and among the first developers of real-time nationwide electronic disease surveillance systems.

MARK MILLER is the executive director of the Medicare Payment Advisory Commission (MedPAC), a nonpartisan federal agency that advises the U.S. Congress on Medicare payment, quality, and access issues. Dr. Miller has more than 20 years of health policy experience and has held several policy, research, and management positions in health care, including assistant director of health and human resources (HHR) at the Congressional Budget Office; deputy director of health plans at the Centers for Medicare & Medicaid Services, health financing branch Chief at the Office of Management and Budget, and senior research associate at the Urban Institute. He earned a Ph.D. in public policy analysis from the State University of New York at Binghamton.

He is a member of the board of trustees of the Consumer Health Foundation in Washington, DC, and of the board of directors of the Essential Hospitals Institute.
