## The Alphabet Soup of Care Delivery Transformation

RANDALL S. BROWN is vice president and director of health research at Mathematica Policy Research. Dr. Brown currently directs an HHS-funded project evaluating several care coordination programs for people with disabilities. In addition, he directs the evaluation of the Comprehensive Primary Care Initiative sponsored by the Center for Medicare and Medicaid Innovation. Over the past 25 years, Dr. Brown has designed and led evaluations of some of the nation's largest demonstration programs in care coordination for people with chronic illness and disabilities. He recently evaluated two demonstrations funded by the Centers for Medicare and Medicaid Services, analyzing effects on service use, costs, quality of care, and patient and physician satisfaction. He has published numerous papers on care coordination, winning awards from AcademyHealth and the National Institute for Health Care Management. In the long-term care area, he led the evaluation of the Cash and Counseling Demonstration program, for which Mathematica won the AcademyHealth 2009 Impact Award. He is principal investigator for the Money Follows the Person program evaluation. Dr. Brown earned his Ph.D in economics at the University of Wisconsin.

**LEEBA LESSIN** is president of CareMore Medical Enterprises, a Medicare Advantage health plan and health care delivery system serving California, Arizona and Nevada. CareMore, a subsidiary of Wellpoint, Inc., specializes in special needs health plans that serve the chronically ill and frail. Before joining CareMore in 2006, Ms. Lessin held several executive positions at PacifiCare Health Systems in California. She was also president and CEO of Monarch Health Systems, a primary care physician system in California, and principal of Lessin Management Associates, where she consulted with medical groups and managed care organizations. Ms. Lessin received her undergraduate degree from Westmont College in Santa Barbara and an MBA from the University of Washington.

ARNOLD MILSTEIN, MD, is a professor at Stanford School of Medicine, and directs the Stanford Clinical Excellence Research Center. The center designs and tests new health care delivery models that it believes will lower per capita health care spending and improve clinical outcomes. He is medical director of the Pacific Business Group on Health, and guides employer-sponsored, clinically-based innovation development for Mercer Health and Benefits. Dr. Milstein also chairs the steering committee that directs the physician pay-for-performance program operated by the Integrated Healthcare Association. Previously, he co-founded the Leapfrog Group and the Consumer-Purchaser Disclosure Project, and served as a member of the Medicare Payment Advisory Commission. He is an elected member of the Institute of Medicine, and chaired an IOM committee that examined methods of lowering per capita health care spending and improving clinical outcomes. Dr. Milstein received an undergraduate degree in economics from Harvard, a medical degree from Tufts, and a master of public health degree from the University of California, Berkeley.

SAMUEL R. NUSSBAUM, MD, is chief medical officer and executive vice president for clinical health policy at WellPoint, Inc., and oversees medical and pharmacy policy to ensure the provision of clinically-proven, effective care. Dr. Nussbaum collaborates with physicians, hospitals and national policy and health care organizations to shape an agenda for quality, safety and clinical outcomes for WellPoint members. Dr. Nussbaum serves on the boards of the National Quality Forum, the OASIS Institute and BioCrossroads. He has served as president of the Disease Management Association of America, chairman of the National Committee for Quality Health Care, chairman of the Chief Medical Officer Leadership Council of America's Health Insurance Plans, and member of the AHIP Board.
