CATHY VAN BEEK is acting chair of the executive board of the Dutch Healthcare Authority, the NZa. Apart from her role as chair, the main topics in the portfolio of van Beek include the curative markets, innovation, and quality of care. Van Beek has extensive managerial experience in the Dutch hospital sector. Her last position before joining the NZa was chair of the executive board at Sint Maartenskliniek, a specialised hospital and centre of excellence for orthopaedic surgery, rheumatology, and rehabilitation. Van Beek has been active in many different supervisory and advisory boards both within and outside the healthcare sector. Van Beek also coaches potential managers in the health care sector.

KARL LAUTERBACH is director of the Institute of Health Economics and Clinical Epidemiology (IGKE) at the University of Cologne and adjunct professor at the Harvard School of Public Health. From 1996 to 1998 he was director of the Institute of Health Economics, Medicine, and Society (IGMG), University of Cologne. Prior to that, he was an assistant professor at the Harvard School of Public Health, Boston University, and Harvard Medical School. His areas of expertise are methodological aspects of health economics, evidence-based medicine, primary and secondary prevention, managed care, cost-effectiveness analysis, and the ethics of resource allocation. Lauterbach serves as an adviser to the Federal Minister of Health and Social Security and is a member of the German Bundestag. He holds a medical degree from Heinrich-Heine University, as well as an M.P.H. and Ph.D. from Harvard School of Public Health.

DOMINIQUE POLTON is director of strategy and research at CNAMTS, the French National Health Insurance Fund for salaried workers, a public compulsory health insurance covering 85 percent of the population and having extended responsibilities in the regulation of the health care system. Prior to working at CNAMTS, she was director of the Institute for Research and Information in Health Economics (IRDES). She is a member of the French National Council for the Future of Health Insurance.

JOHN ROTHER is Executive Vice President of Policy and Strategy for AARP. He is responsible for the federal and state public policies of the Association, and for formulating AARP's overall strategic direction. He is an authority on Medicare, managed care, long-term care, Social Security, pensions and the challenges facing the boomer generation. Prior to coming to AARP in 1984, Mr. Rother served eight years with the U.S. Senate as Special Counsel for Labor and Health to former Senator Jacob Javits (R-NY), then as Staff Director and Chief Counsel for the Special Committee on Aging under its Chairman, Senator John Heinz (R-PA). He serves on several Boards and Commissions, including as the Chair of Generations United and Vice-Chair of the National Quality Forum. He also serves on the Boards of Pension Rights Center, the Alliance for Health Reform, and advisory Boards to Kaiser Permanente, Google, and several Congressional fellowships. He is a frequently quoted in the news and regularly presents at conferences and congressional briefings.
