### **“WHO’S COUNTING: What is crowd-out, how big is it and does it matter for SCHIP?”**

**LISA DUBAY** is an associate professor at the Johns Hopkins Bloomberg School of Public Health. Prior to this, she was a principal research associate at the Urban Institute where she focused on the effects of public policies on insurance coverage, access to care, and health outcomes for low-income populations. Dr. Dubay has led several national evaluations of public expansions in coverage for federal agencies and private foundations. She has written extensively on the extent to which expansions in public coverage lead to reductions in uninsurance and improvements in access to care. Also, she recently completed a study that estimated the share of uninsured children, parents, and childless adults who are eligible for public programs, are unable to afford health insurance, and are likely to be able to afford coverage. Dr. Dubay received a Ph.D. from the Johns Hopkins Bloomberg School of Public Health, an Sc.M. in Health Policy and Management from the Harvard School of Public Health, and a B.A. from Tufts University.

**ANN CLEMENCY KOHLER** was promoted to deputy commissioner of the New Jersey Department of Human Services in March 2007. She began her career in healthcare administration thirty years earlier with the Division of Medical Assistance and Health Services and rose through the ranks to the position of deputy director in 1993. After leaving state government to work for a health maintenance organization (HMO), she returned in 1996 as Medicaid director for the State of New York, the largest Medicaid agency in the country. In 2000, Ms. Kohler returned to New Jersey and was appointed to a management position in the Office of Management and Budget (OMB). While at OMB, she was responsible for the oversight of the budget and fiscal operations for both the Departments of Human Services and Health and Senior Services. Ms. Kohler was appointed director of the New Jersey Division of Medical Assistance and Health Services in 2002. She received a B.A. and M.Sc. in City and Regional Policy from Rutgers State University.

**PETER ORSZAG** is the director of the Congressional Budget Office (CBO), a post he assumed in January 2007. Before joining the CBO, Dr. Orszag was the Joseph A. Pechman Senior Fellow and deputy director of Economic Studies at the Brookings Institution, where he served as the director of the Hamilton Project, director of the Retirement Security Project, and co-director of the Tax Policy Center. He served as special assistant to the President for Economic Policy and senior economic adviser at the National Economic Council from 1997-1998. He has coauthored numerous books, including *Protecting the Homeland 2006/7* (2006), *Aging Gracefully: Ideas to Improve Retirement Security in America* (2006), and *Saving Social Security: A Balanced Approach* (2004). His main areas of research have been Social Security budget policy, pensions, macroeconomics, tax and budget policy and higher education policy. Dr. Orszag graduated *summa cum laude* in economics from Princeton University and also obtained a M.Sc. and a Ph.D. in economics from the London School of Economics.

**JANET TRAUTWEIN** is executive vice president and CEO of the National Association of Health Underwriters (NAHU) in Arlington, Virginia. Her responsibilities include oversight of all NAHU activities and primary representation of the association to the media, government agencies, elected officials, the insurance industry, and the public.
