JO –ELLEN ABOU NADER has been with Express Scripts for 14 years in audit and fraud roles. She has been in audit functions related to Financial, Operational, Client, and Retail Network Audit, and Fraud, Waste & Abuse. She has developed numerous fraud analytics scenarios to identify prescription fraud. Today, Ms. Abou Nader is responsible for the fraud and retail network audit programs for Commercial, Medicare Part D, Medicaid, Department of Defense and Workers Compensation clients. She has extensive knowledge in the prescription fraud field. She is a Certified Internal Auditor and Certified Fraud Examiner. In addition, she holds a Certification in Risk Management Assurance from the Institute of Internal Auditors. Ms. Abou Nader was appointed the first President of the Missouri National Association of Drug Diversion Investigators. She has been a champion behind establishing industry collaboration in the prescription fraud detection space. Ms. Abou Nader is a graduate from the University of Central Florida in Accounting and Business Administration.

GRANT BALDWIN is the director of the Division of Unintentional Injury Prevention at the National Center for Injury Prevention and Control, and has been in this position since 2008. In this role, Dr. Baldwin provides overall scientific and programmatic leadership for the Division. Some of the topic areas Dr. Baldwin oversees include prescription drug overdose prevention, motor vehicle injury prevention, traumatic brain injury, and falls prevention. Dr. Baldwin joined the Injury Center in November 2006 as the acting deputy director. Prior to this appointment, Dr. Baldwin served as a senior advisor in the Coordinating Center for Environmental Health and Injury Prevention and the National Center for Environmental Health / Agency for Toxic Substances and Disease Registry. Dr. Baldwin also spent several years in the ATSDR Division of Health Education and Promotion as a team leader in a group educating community members and health professionals about preventing exposure to toxic substances. He began his career at CDC in September 1996. Dr. Baldwin received his PhD in Health Behavior and Health Education at the University of Michigan School of Public Health in 2003. He also received a MPH in Behavioral Sciences and Health Education from the Rollins School of Public Health at Emory University in 1996.

SARAH CHOUINARD is the medical director of Community Care of West Virginia. She has an undergraduate degree in neurobiology from the University of Vermont and conducted scientific research at the University of California, San Diego after graduating magna cum laude from The University of Vermont. Research in biomedical health sciences peaked Dr. Chouinard's interest in medicine. She is an alpha omega alpha graduate of Marshall University's School of Medicine in West Virginia and served as chief resident in the Department of Family and Community Health. Since 2003, in addition to serving as the medical director of Community Care of West Virginia (a federally-qualified health center), she has served as the chief clinical advisor for the Community Health Network of West Virginia. In recognition of her efforts, Dr. Chouinard was asked to testify at The President's Council of Advisors on Science and Technology (PCAST) Workgroup hearing. She now serves as an advisor to the West Virginia Health Improvement Institute on health system transformation and pay-for-performance initiatives. Dr. Chouinard served as lead physician for the Meaningful Use Vanguard Group for the state's Regional

Extension Center. She also has had the opportunity to participate in an expert panel with Health Resources and Services Administration for health system realignment. She is an executive member of the West Virginia Health Information Network board of directors, WV's state HIE agency. Dr. Chouinard serves as medical director for the state insurer, Public Employees Insurance Agency (PEIA). She was recognized by the West Virginia Rural Health Association as "Rural Practitioner of the Year" in 2008 and was recently featured in stories by Governing magazine and CNN on health reform. She is a co-founder of the Fayetteville Skate Park, a multi-faceted recreational facility promoting physical activity and wellness. For her efforts in promoting free healthy activities for her community, Dr. Chouinard was recognized as Fayetteville's "Citizen of the Year."
