Healthier and Wealthier, or Sicker and Poorer? Prospects for Medicare Beneficiaries Now and in the Future January 13, 2014

James C. Capretta is a senior fellow at the Ethics and Public Policy Center (EPPC) and a visiting fellow at the American Enterprise Institute (AEI). At EPPC and AEI, he builds on over two decades of experience as a senior analyst to study and provide commentary on a wide range of public policy and economic issues with a focus on health care entitlement reform, U.S. fiscal policy, and global population aging. Mr. Capretta's essays and articles have been featured in numerous print and online publications, and he appears regularly as a witness at congressional hearings and as commentator on prominent television and radio programs. From 2001 to 2004, Mr. Capretta served as an associate director at the White House Office of Management and Budget, where he had lead responsibility for health care, Social Security, education, and welfare programs. He also served for a decade in Congress as a senior analyst for health and entitlement issues.

GRETCHEN JACOBSON is an associate director with the Kaiser Family Foundation's Program on Medicare Policy, where she directs and conducts a variety of projects pertaining to the Medicare program and the population it serves. Prior to joining the Kaiser Family Foundation in December 2008, Dr. Jacobson was an analyst in health care financing at the Congressional Research Service; she has also held positions where she directed research on the future market value of pharmaceuticals, medical devices and health services. Her research has appeared in clinical and policy peer-reviewed journals. Dr. Jacobson received her Ph.D. in health economics from the Johns Hopkins School of Public Health and her M.S. in epidemiology from the Harvard School of Public Health.

MARILYN MOON is an institute fellow at the American Institutes for Research (AIR) and director of the Center on Aging. From 2003 to 2013, she directed the Health Program at AIR. An economist and expert on Medicare, aging, consumer health issues and health care financing, Dr. Moon has also served as a senior fellow at the Urban Institute and as a public trustee for the Social Security and Medicare trust funds. From 2008 through 2012, she chaired the Maryland Health Care Commission. She has written extensively on health policy and other social insurance issues; she wrote a column on health reform for *The Washington Post* in the 1990s. She has served on a number of boards for non-profit organizations, including the Medicare Rights Center and the National Academy of Social Insurance. She is a member of the Institute of Medicine. Dr. Moon earned a Ph.D. in economics from the University of Wisconsin–Madison.

PATRICIA NEUMAN is a senior vice president of the Henry J. Kaiser Family Foundation and is director of its Program on Medicare Policy. Dr. Neuman is widely regarded as an expert on Medicare policy issues. She has published numerous articles on topics related to health coverage and financing for the Medicare population, and has been invited several times to present expert testimony before congressional committees. Dr. Neuman's work at the Foundation focuses on a broad range of issues pertaining to the Medicare program and the population it serves. Before joining the Foundation in 1995, Dr. Neuman served for six years on the professional staff of the

Ways and Means Subcommittee on Health in the U.S. House of Representatives, and for three years on the staff of the U.S. Senate Special Committee on Aging working on health and long-term care issues. Dr. Neuman received a doctorate of science degree in health policy and management and a master of science degree in health finance and management from the Johns Hopkins School of Public Health in Baltimore, Maryland. She received her bachelor's degree from Wesleyan University in Middletown, Connecticut.

Daniel Perry is the president and founder of the not-for-profit Alliance for Aging Research in Washington, DC. Established in 1986, the alliance is a leading U.S. citizen advocacy organization promoting a broad agenda of medical and scientific research to improve health and independence as people grow older. Mr. Perry's background spans a wide range of health policy, governmental, political and journalistic experience. He held staff positions for more than a dozen years on Capitol Hill in Washington, DC. He has been a key advisor on aging and medical research policies to Democratic and Republican legislators and presidents. He has led a number of large coalitions advancing research in aging, Alzheimer's disease, physical frailty, and for embryonic stem cell research. He has served as an advisor to the Institute on Aging of the University of Pennsylvania Medical School, and as a member of the New York Academy of Sciences and the National Advisory Council on Aging – having been appointed in 2010 by Health and Human Services Secretary Kathleen Sebelius. He was a 2012 featured speaker at the first TEDMED gathering in the nation's capital. As a journalist Mr. Perry received many awards and citations, including a nomination for the Pulitzer Prize.
