## The Story Behind Pioneer ACOs: Lessons Learned from Participants and Dropouts September 23, 2013

Anne-Marie Audet, is vice president for the Delivery System Reform & Breakthrough Innovations programs at The Commonwealth Fund and an assistant professor of medicine and public health at Cornell University. Dr. Audet has worked in the field of health system quality improvement for over 20 years. Previously, Dr. Audet worked in policy analysis at the American College of Physicians and led the implementation of the Medicare Health Care Quality Improvement Program in Massachusetts while working at the Massachusetts Peer Review Organization. She was also co-editor of "Clinical Crossroads," a series published monthly in the *Journal of the American Medical Association*. Dr. Audet was appointed to the Institute of Medicine Subcommittee on Quality Improvement Organizations' Evaluation and was a founding board member of the Massachusetts Medical Society and Alliance Charitable Foundation Board where she now serves as a special advisor. Dr. Audet holds a B.S. in cell and molecular biology and an M.D. and M.S. in epidemiology from McGill University. She also holds an S.M. in health policy and management from Harvard University.

ELLIOTT FISHER, IS professor of medicine at the Geisel School of Medicine at Dartmouth, and director of The Dartmouth Institute for Health Policy & Clinical Practice, and co-director of the Dartmouth Atlas of Health Care. His early work focused on exploring the causes and consequences of variations in health care utilization and spending. He directed the research and helped coordinate the policy initiatives that led to the implementation of accountable care organizations (ACOs) in the United States. His research now focuses on exploring the determinants of successful ACO formation and on evaluating the impact of health reforms on health system performance. He has published nearly 150 articles in leading journals and is a member of the Institute of Medicine of the National Academy of Sciences. Dr. Fisher received his undergraduate and medical degrees from Harvard University and completed his internal medicine residency and public health training at the University of Washington.

STEVEN M. SAFYER, is president and chief executive officer of Montefiore in New York City. Montefiore is the university hospital and academic medical center for Albert Einstein College of Medicine and a full-service, integrated delivery system caring for patients from the New York metropolitan region. Dr. Safyer has been at Montefiore since 1982, previously serving as senior vice president and chief medical officer. He is board certified in internal medicine and is a professor of medicine in the department of medicine, and professor of epidemiology and population health in the department of epidemiology and population health at Einstein. Dr. Safyer currently chairs the League of Voluntary Hospitals and Homes and is past chairman of the board of governors for the Greater New York Hospital Association. He is a board member of the Hospital Association of New York State, Association of American Medical Colleges' Council of Teaching Hospitals, The Macy's Foundation, New York eHealth Collaborative, Coalition to protect America's Health Care, and University HealthSystem Consortium. He is an active participant on committees for organizations such as the Association of American Medical Colleges, New York State Council on Graduate Medical Education, Medicaid Redesign Team, and Chase Regional Advisory Board. He was the previous chair of the Bronx Regional Health

Information Organization. Dr. Safyer received his Bachelor of Science degree from Cornell University and his medical degree from Albert Einstein College of Medicine.

GREGORY S. SHEFF, is executive vice president of clinical systems at Seton Healthcare Family. Dr. Sheff began working with Seton in 2012 as president and chief medical officer of Seton Health Alliance, an accountable care organization formed by Seton and Austin Regional Clinic. Prior to joining Seton in 2013, Dr. Sheff was medical director of Care Management and Clinical Integration for Austin Regional Clinic and senior vice president of managed care for Covenant Management Systems, a management services organization. He served on the executive board of Austin Regional Clinic and continues to serve on the board of Covenant Management Systems. He also serves on the boards that oversee the Seton Family of Hospitals, Seton Insurance Services and Seton Clinical Enterprise. Dr. Sheff is the recipient of *Texas Monthly's* Super Doctors award, *Austin Monthly's* Annual Best Doctor award and Vitals.com Patient Choice award. A board-certified family medicine physician, Dr. Sheff continues to care for patients at Austin Regional Clinic.
