Tools for Patients: Data, Technology and Communication in Patient-Centered Care

BENJAMIN MOULTON is the Senior Vice President for Policy and Advocacy at the Informed Medical Decisions Foundation, which is a subdivision of the non-profit HealthWise. He is an adjunct professor of health law at the Boston University Law School, and an adjunct lecturer in health law at the Harvard School of Public Health, in Boston, Massachusetts. At the Foundation, Ben provides educational outreach to key stakeholders and policy makers regarding shared decision making. Prior to joining the Foundation, he served as legal counsel to George Washington Medical Center, which involved providing legal advice to an academic medical center, a teaching hospital, medical school and over 1,000 affiliated physicians. He also served as the executive director of the American Society of Law, Medicine & Ethics (ASLME) for over 15 years where he engaged in legal research for a variety of public and private grants. He has convened over 100 medical legal conferences and as executive director oversaw operations for ASLME which included the production of two peer-reviewed journals, the Journal of Law, Medicine & Ethics and the American Journal of Law & Medicine.

NIALL BRENNAN is CMS' Chief Data Officer and the Director of the Office of Enterprise Data and Analytics (OEDA). In this capacity, he oversees improvements in data collection and dissemination at CMS and efforts to help CMS better harness its vast data resources to drive higher quality, patient-centered care at a lower cost. Niall directs leading-edge research and analysis published by CMS, as well as efforts to make its considerable data sets available to external researchers seeking to promote better understanding of health care in the United States. He also manages CMS' extensive data and information product portfolio. Prior to joining CMS, Niall worked at the Brookings Institution, the Medicare Payment Advisory Commission, the Congressional Budget Office, The Urban Institute, and Price WaterhouseCoopers. He is a graduate of University College Dublin, and earned a master's degree in Public Policy from Georgetown University.

ROBIN GELBURD is the President of FAIR Health, Inc., a national, independent nonprofit bringing transparency to healthcare costs and insurance through data products, research resources and consumer engagement using its database of over 18 billion private insurance claims. FAIR Health operates a consumer website that provides look-up tools for medical and dental costs and information on healthcare and insurance. Previously, she served for eight years as General Counsel of a medical research foundation comprised of approximately 30 academic medical centers, hospitals, and research institutions in New York, dedicated to the promotion of medical research. Robin was appointed Chairperson of New Yorkers for the Advancement of Medical Research, a statewide coalition of over 40 organizations, which she helped found in 2003. Early in her career, Robin clerked for the U.S. Court of Appeals (4th Circ.). She worked as a litigator at Morrison & Foerster LLP and as a healthcare law partner at a predecessor of Manatt, Phelps & Phillips LLP. She earned her B.A. at the State University of New York at Binghamton and her J.D. at the Cardozo School of Law, Yeshiva University.

TIM SKEEN is Vice President of Marketplace Solutions in the Information Technology division of Anthem. Marketplace Solutions comprises four technology towers aligned to Anthem's external facing strategic pillars: Consumer Centricity, Provider Collaboration, Cost of Care Management, and Innovation. Prior to transitioning to this role, he was the Chief Information Officer (CIO) for the Government Business Division (GBD) of Anthem, Inc.
