### **Medicare and Prescription Drug Prices**

**GERARD ANDERSON** is a professor of health policy and management and director of the Johns Hopkins Center for Hospital Finance and Management. Prior to coming to Johns Hopkins in 1983, Dr. Anderson worked in the Office of the Secretary of the U.S. Department of Health and Human Services from 1978 to 1983. While in the Office of the Secretary, Dr. Anderson worked primarily on health care financing issues and was one of the principle architects of the Medicare Prospective Payment System. Dr. Anderson is currently conducting research on chronic conditions, drug pricing, comparative insurance systems, medical education, health care payment reform, and technology diffusion. He has directed reviews of health care systems for the World Bank, World Health Organization and USAID in multiple countries and has directed over 100 research projects. He has authored two books on health care payment policy, published over 250 peer-reviewed articles, testified in Congress 50 times, and serves on multiple editorial committees.

**LAURA M. KEOHANE** is an assistant professor of health policy at the Vanderbilt University School of Medicine. Her research focuses on policy issues that impact individuals who face health care barriers due to age, disability, and socioeconomic circumstances. Keohane's current projects focus on dual Medicare-Medicaid enrollment, benefit design for post-acute services, and Medicare spending trends. Keohane completed her doctoral degree in Health Services Research at Brown University in 2015. She holds a B.A. from Wesleyan University and a M.S. in health policy and management from the Harvard School of Public Health. She previously worked in clinical research, disease management services, and legal advocacy for individuals with disabilities.

**MARK MCCLELLAN** is director of the Duke-Robert J. Margolis, MD, Center for Health Policy and senior fellow and director of the Health Care Innovation and Value Initiative at the Brookings Institute. A doctor and economist by training, he also has a highly distinguished record in public service and in academic research. Dr. McClellan is a former administrator of the Centers for Medicare & Medicaid Services (CMS) and former commissioner of the U.S. Food and Drug Administration (FDA), where he developed and implemented major reforms in health policy. These include the Medicare prescription drug benefit, FDA's Critical Path Initiative, and public-private initiatives to develop better information on the quality and cost of care. Dr. McClellan chairs the Reagan-Udall Foundation, is co-chair of the Quality Alliance Steering Committee, sits on the National Quality Forum's Board of Directors, is a member of the Institute of Medicine, and is a research associate at the National Bureau of Economic Research. He previously served as a member of the President's Council of Economic Advisers and senior director for health care policy at the White House and was an associate professor of economics and medicine at Stanford University.

## **MODERATORS**

**SHAWN BISHOP** serves as vice president of the Advancing Medicare and Controlling Health Care Costs programs at The Commonwealth Fund. Prior to the Fund, Ms. Bishop served as senior professional staff to the U.S. Senate Finance Committee under Chairman Max Baucus from 2005-2010, where she had primary responsibility for Medicare Parts C and D and other issues such as comparative effectiveness research. She served as a principal analyst at the Congressional Budget Office from 2002-2005 and 1996-1999, as a health insurance specialist at the Centers for Medicare and Medicaid Services from 1999-2002, and as a policy analyst at Price Waterhouse, LLC, and the Prospective Payment Assessment Commission (predecessor to MedPAC) from 1994-1996. From 2010-2015, she owned and operated SB Health Policy Consulting to provide strategic analysis related to health care and the Affordable Care Act and served as senior vice president of a financial services consulting firm. Ms. Bishop holds an M.P.P. from the University of California, Berkeley, and a B.A. in English Literature from the University of California, Irvine.

**SARAH DASH** is president and co-CEO of the Alliance for Health Reform. Sarah joined the Alliance in April 2014 as vice president for policy. She was previously a member of the research faculty at the Georgetown University Health Policy Institute in the Center on Health Insurance Reforms, where she conducted research and analysis of the rollout of health insurance marketplaces under the Affordable Care Act. Ms. Dash also served as a senior health policy aide to Sen. Jay Rockefeller (D-W.Va.) and Rep. Rosa DeLauro (D-Conn.). She received her Master's in Public Health from Yale University and a Bachelor of Science from MIT.
