STUART A. GUTERMAN is vice president of Medicare and Cost Control at The Commonwealth Fund. He leads the Fund's special initiative on Advancing Medicare, which supports analysis of data and development of policies to improve Medicare. He also staffs the Fund's special initiative on Controlling Health Costs, which focuses on identifying and addressing the drivers of health care spending. Mr. Guterman was executive director of The Commonwealth Fund's Commission on a High Performance Health System from 2011 to 2013, and previously directed the Fund's Program on Payment and System Reform and its Program on Medicare's Future. Before coming to the Fund, he directed the Office of Research, Development, and Information at the Centers for Medicare and Medicaid Services. Prior to that, he was a senior analyst at the Congressional Budget Office, a principal research associate in the health policy center at the Urban Institute, and deputy director of the Medicare Payment Advisory Commission. Previously, Mr. Guterman was chief of institutional studies in the Health Care Financing Administration's Office of Research, where he directed the evaluation of the Medicare Prospective Payment System for inpatient hospital services and other intramural and extramural research on hospital payment. He holds an A.B. in economics from Rutgers College and an M.A. in economics from Brown University, and did further work toward a Ph.D. in economics at the State University of New York at Stony Brook.

MARK A. MCCLELLAN is a senior fellow and director of the Health Care Innovation and Value Initiative at the Brookings Institution. His work focuses on promoting quality and value in patient-centered health care. Dr. McClellan is the co-director of the Bipartisan Policy Center's Leaders' Project on the State of American Health Care; co-chair of the Robert Wood Johnson Foundation Commission to Build a Healthier America; and chair of the Food and Drug Administration's Reagan-Udall Foundation. He is also co-chair of the Quality Alliance Steering Committee, sits on the National Quality Forum's Board of Directors, and is a research associate at the National Bureau of Economic Research. Dr. McClellan is a former administrator of the Centers for Medicare & Medicaid Services, and former commissioner of the Food and Drug Administration (FDA), where he developed and implemented the Medicare prescription drug benefit and the FDA's Critical Path Initiative. He served as a member of the President's Council of Economic Advisers, was senior director for health care policy at the White House, and was an associate professor of economics and medicine at Stanford University. Dr. McClellan holds an M.D. from the Harvard University–Massachusetts Institute of Technology Division of Health Sciences and Technology, a Ph.D. in economics from MIT, an M.P.A. from Harvard University, and a B.A. from the University of Texas at Austin.

DAVID A. SHARE is senior vice president of Value Partnerships at Blue Cross Blue Shield of Michigan. Dr. Share serves as a director and the secretary of the Washtenaw Health Plan, a county health insurance program for indigent people with no source of health insurance. He is a fellow of the American College of Preventive Medicine. Dr. Share serves as chair of the board of directors of the Michigan State Medical Society (MSMS).

He chaired the MSMS Committee on Michigan's Public Health from 2000 to 2011, served as the chair of the MSMS Task Force on the Future of Medicine, as well as the Community Wellness working group of the Future of Medicine Task Force. In 2000 he was president of the Washtenaw County Medical Society. Dr. Share served on the Commission for a High Performance Health System of The Commonwealth Fund. Dr. Share also served for 30 years as founding medical director of The Corner Health Center in Ypsilanti, a community-based health center for teenagers and their children, where he still practices medicine. Dr. Share earned his A.B., M.P.H. and M.D. from the University of Michigan, where he is an adjunct clinical assistant professor in the Departments of Family Medicine and Pediatrics.

GAIL R. WILENSKY is an economist and senior fellow at Project HOPE, an international health foundation. She directed the Medicare and Medicaid programs and served in the White House as a senior adviser on health and welfare issues during the administration of President George H.W. Bush. She was also the first chair of the Medicare Payment Advisory Commission. Her expertise is on strategies to reform health care, with particular emphasis on Medicare, comparative effectiveness research and military health care. Dr. Wilensky currently is a trustee of the Combined Benefits Fund of the United Mine Workers of America and the National Opinion Research Center, is on the board of regents of the Uniformed Services University of the Health Sciences (USUHS), the visiting committee of the Harvard Medical School and the board of directors of the Geisinger Health System Foundation. She is an elected member of the Institute of Medicine and has served two terms on its governing council. She is a former chair of the board of directors of Academy Health and a former trustee of the American Heart Association. She is also a director of Brainscope, Quest Diagnostics and United HealthGroup. Dr. Wilensky testifies frequently before congressional committees and is an adviser to members of Congress and other elected officials. She received an A.B. in psychology and a Ph.D. in economics at the University of Michigan, and has received several honorary degrees.
