Stabilizing U.S. Health Spending: Approaches to Bending the Cost Curve

DAVID BLUMENTHAL is president of The Commonwealth Fund. Dr. Blumenthal is formerly the Samuel O. Thier Professor of Medicine at Harvard Medical School and Chief Health Information and Innovation Officer at Partners Healthcare System in Boston. He is also chairman of The Commonwealth Fund Commission on a High Performance Health System. From 2009 to 2011, he served as the National Coordinator for Health Information Technology, with the charge to build an interoperable, private, and secure nationwide health information system and to support the widespread, meaningful use of health IT. Previously, Dr. Blumenthal was a practicing primary care physician, director of the Institute for Health Policy, and professor of medicine and health policy at Massachusetts General Hospital/Partners Healthcare System and Harvard Medical School. He is the author of more than 250 books and scholarly publications, including most recently, Heart of Power: Health and Politics in the Oval Office. He is a member of the Institute of Medicine and a former board member and national correspondent for the *New England Journal of Medicine*. He has also served on the staff of the U.S. Senate Subcommittee on Health and Scientific Research; is the founding chairman of AcademyHealth, the national organization of health services researchers; and a trustee of the University of Pennsylvania Health System. Dr. Blumenthal received his undergraduate, medical, and public policy degrees from Harvard University and completed his residency in internal medicine at Massachusetts General Hospital. He has held several leadership positions in medicine, government, and academia, including senior vice president at Boston's Brigham and Women's Hospital and executive director of the Center for Health Policy and Management and lecturer on public policy at the Kennedy School of Government.

ROBERT S. GALVIN is chief executive officer of Equity Healthcare and operating partner of The Blackstone Group. Before joining Blackstone, Dr. Galvin was executive director of health services and chief medical officer for General Electric (GE) for fifteen years, where he was in charge of the design, financial and clinical performance of GE's health programs. He was also responsible for health policy strategies affecting employees. His work has been widely published in the *New England Journal of Medicine* and *Health Affairs*, and he was a co-founder of the Leapfrog Group and founder of two other groups, Bridges to Excellence/PROMETHEUS and Catalyzing Payment Reform. Dr. Galvin is a member of the Institute of Medicine, a branch of the National Academy of Science, and sits on the IOM's Board on Health Care Services. He is also on the board of Vanguard Health Systems and the non-profit National Quality Forum. Dr. Galvin is Professor Adjunct of Medicine and Health Policy at Yale. His work has received awards from the National Business Group on Health, the Healthcare Financial Management Association and the National Coalition for Cancer Survivorship. He is a fellow of the American College of Physicians.

STUART GUTERMAN is vice president and executive director of the Commonwealth Fund's Commission on a High Performance Health System. The commission is charged with promoting a high-performing health system that provides all Americans with affordable access to high-quality, safe care while maximizing efficiency in its delivery and administration. Mr. Guterman was director of the Office of Research, Development, and Information at the Centers for Medicare and Medicaid Services from 2002 to 2005. Prior to that, he was a senior analyst at the Congressional Budget Office, a principal research associate in the health policy center at the Urban Institute, and deputy director of the Medicare Payment Advisory Commission (and its predecessor, the Prospective Payment Assessment Commission) from 1988 through 1999. Previously, Mr. Guterman was chief of institutional studies in the Health Care Financing Administration's Office of Research, where he directed the evaluation of the Medicare Prospective Payment System for inpatient hospital services and other intramural and extramural research on hospital payment. He holds an A.B. in economics from Rutgers College and an M.A. in economics from Brown University, and did further work toward a Ph.D. in economics at the State University of New York at Stony Brook.

KAREN IGNAGNI is president and chief executive officer of America's Health Insurance Plans (AHIP). Ms. Ignagni has earned recognition by leading publications, including the *New York Times*, *National Journal*, *The Hill*, *Time Magazine*, *The Washingtonian*, *Fortune Magazine*, and *Modern Healthcare*, for her extensive health policy background and intrinsic feel for politics. Ms. Ignagni is one of only eight individuals to be included in *Modern Healthcare's* annual rankings of the "Most Influential People in Healthcare" for each year of its existence. Ms. Ignagni joined the organization as its chief executive in 1993. Prior to that, she directed the AFL-CIO's Department of Employee Benefits. In the 1980s, she was a professional staff member on the U.S. Senate Labor and Human Resources Committee, preceded by work at the Committee for National Health Insurance and the U.S. Department of Health and Human Services.
