#### 1:30 - 2:25 p.m. ET | Defining "Essential" in Essential Worker

"Essential workers" has taken many meanings during the pandemic. Frontline health care workers were critical to our public health response. Many other Americans, including grocery store, postal service, and public transit workers, among others, continued to ensure vital infrastructures and services were maintained over the past 15 months. Still, others found it personally essential that they continue to work, in potentially unsafe conditions, to provide for themselves and their families. At the policy level, states and localities also set their own definitions for which workers and what types of work were considered "essential" to keep local economies afloat, which led to significant differences between regions and challenges in enforcing lockdown measures.

Experts on this panel discussed the impact that different "essential worker" definitions had on various levels of government and economies, and explored how workforce policies may change or adapt post-COVID.
